DRAFT MINUTES

San Francisco County Transportation Authority

Tuesday, May 21, 2024

1. Roll Call

Chair Mandelman called the meeting to order at 10:01 a.m.

2. Chair's Report - INFORMATION

Chair Mandelman announced that this month the Transportation Authority joined the Transbay Joint Powers Authority (TJPA) in celebrating the Federal Transit Administration's (FTA's) proposed commitment of \$3.4 billion to The Portal, through its Capital Investment Grant (CIG) program. He added that in addition to being rated Medium-High in its performance and granted entry to the Engineering phase of FTA's CIG program, The Portal has been recommended for \$500 million in President Biden's Fiscal Year 2025 budget.

Chair Mandelman expressed appreciation for the FTA's strong funding partnership to deliver The Portal, which will help realize the project's extensive regional, statewide and national benefits, in the areas of connectivity, climate, and economic development. He also stated the Portal will bring Caltrain and High Speed Rail to the heart of downtown at Salesforce Transit Center, connecting 11 different public transportation services at the region's premier transit hub.

Chair Mandelman commented that the FTA's funds leverage and build upon the Transportation Authority's prior investment and in the broader Transbay and Peninsula Rail Corridor program. He added that funding included \$500 million, or 20%, of the funds for Salesforce Transit Center, \$41 million toward Caltrain Electrification, and a \$340 million commitment for The Portal, from the Transportation Authority's Prop K and L sales tax and other funds it programs.

Chair Mandelman said that the Transportation Authority celebrated these exciting milestones yesterday with the TJPA and Caltrain Chair Jeff Gee, Speaker Pelosi, State Senator Scott Wiener, and Mayor Breed, and many other state and regional partners. He stated the event culminated the work of several people including former Transportation Authority Chair and now President Peskin for his leadership to re-set and regionalize The Portal project 4 years ago with the creation of the 6-agency integrated team. Chair Mandelman said he had issued them a challenge at the time to undertake a 3-year accelerated work program to seek Federal funds, and with a lot of hard work and collaboration, they completed it.

Chair Mandelman recognized Transportation Authority staff Jesse Koehler, along with Carl Holmes, Anna Laforte, and Director Chang. He said the \$3.4 billion federal commitment now brings the project to **two-thirds** funded and positions the project well for the Metropolitan Transportation Commission's highest regional endorsement as a Tier 1 project, as well as for seeking further state and federal grants to complete the funding plan.

Chair Mandelman congratulated Commissioner Dorsey, the San Francisco Municipal Transportation Agency (SFMTA), and SF Public Works on the Folsom Streetscape Groundbreaking last week. He said this project will realize the community's vision for a two-way protected bicycle lane, dedicated transit lane, raised crosswalks, and loading and parking improvements to optimize curb space. He added the project will also beautify the public realm with pedestrian-scale lighting and civic amenity zones. He noted the Transportation Authority will provide \$11.4 million for this transformative project and looked forward to seeing the finished result.
