

# Regional Measure 3 State Authorizing Legislation



- RM3 developed at the state level with input and advocacy from stakeholders
- Senate Bill 595 (Beall) set:
  - ► Toll amount: up to \$3 increase
  - Expenditure Plan: includes both specific projects and broad funding categories
  - Process requirements for both capital projects and operating program

# Regional Measure 3 Passed by Voters June 5, 2018

REGIONAL MEASURE 3 > PROCESS

#### Ballot measure authorizes phased-in toll

- ▶ Jan. 2019: \$1 increase
- ▶ Jan. 2022: \$1 increase
- ▶ Jan. 2025: \$1 increase
- Requires that BATA hold a public hearing on the proposed toll increase (Nov. 28, 2019)
- Requires that project sponsors submit Initial Project Reports to MTC within 6 months of the election

# Regional Measure 3 Implementation San Francisco Priorities

REGIONAL MEASURE 3 > SF PRIORITY PROJECTS

#### Regional Programs

- BART Expansion Cars (\$500 million)
- Ferry Enhancement Program (\$300 million)
- Bay Area Express Lanes (\$300 million)









# Regional Measure 3 Implementation: San Francisco's Priorities

REGIONAL MEASURE 3 > SF PRIORITY PROJECTS

- Central Corridor (SF-Oakland Bay Bridge)
  - Caltrain Downtown Extension (\$325 million)
  - Transbay Rail Crossing (\$50 million)
  - Muni Fleet Expansion and Facilities (\$140 million)
  - Core Capacity Transit Improvements (\$140 million)









# Regional Measure 3 Implementation: San Francisco's Priorities



- Central Corridor (SF-Oakland Bay Bridge)
  - Muni Fleet Expansion and Facilities (\$140 million)

New Light Rail Vehicles, Muni Metro East Maintenance Facility, Muni Maintenance Facility TBD, Electric Bus Pilot

Core Capacity Transit Improvements (\$140 million)

Muni Forward: L Taraval, SFGo Transit Signal Priority, 16<sup>th</sup> St Corridor Transit Priority, Better Market Street







# Regional Measure 3 Implementation: San Francisco's Priority Projects



- Other RM3 programs of interest to SF that are still under include:
  - San Francisco Bay Trail / Safe Routes to Transit (regional competitive program)
  - Ferry Operating Program
  - Regional Express Bus Operating Program
  - Transbay Terminal Operating Program

# Regional Measure 3 Implementation: Next Steps



**REGIONAL MEASURE 3 > IMPLEMENTATION NEXT STEPS** 

- Work with MTC and project sponsors to refine Initial Project Reports, as needed
- Provide input to MTC/BATA as they develop guidelines for allocation of RM3 funds
- Continue to work with project sponsors, our Board, MTC representatives and state delegation on RM3 implementation
