

# SAN FRANCISCO COUNTY TRANSPORTATION AUTHORITY

### Prop AA Vehicle Registration Fee Overview

- \$10 vehicle registration fee approved by San Francisco voters in 2010
- Generates about \$5 million annually
- 3 categories:
  - Street Repair and Reconstruction 50%
  - Pedestrian Safety 25%
  - Transit Reliability and Mobility Improvements – 25%
- Focus on small, high impact projects that will provide tangible benefits to the public in the short-term
- Design and construction phases
- Strong emphasis on timely use of funds







### Prop AA Vehicle Registration Fee Overview

- Prop AA Expenditure Plan requires adoption of a Strategic
  Plan including a detailed 5-year program of projects (5YPP) prior to allocation of funds
- 2012 Prop AA 5YPPs
  - Fiscal Years 2012/13 2016/17
  - \$27.1 million for 22 projects
- 2017 Prop AA 5YPPs
  - Fiscal Years 2017/18 2021/22
  - \$23.2 million available





### Prop AA Vehicle Registration Fee Policies and Criteria



- 2017 Prop AA Strategic Plan Guidance
  - Prop AA Strategic Plan Policies guide staff and project sponsors on the various aspects of managing the program, including the allocation and expenditure of funds
  - Prop AA Screening and Prioritization Criteria, provide the mechanism to evaluate and prioritize projects for funding within the three programmatic categories
- Competitive call for projects to be released following adoption of Policies and Screening and Prioritization Criteria

November 17, 2016	Workshop for potential applicants (tentative)
January 17, 2017	Applications due (tentative)
February 22, 2017	Citizens Advisory Committee (CAC) – ACTION 2017 Strategic Plan adoption (includes 5-Year Programs of Projects)
March 28, 2017	Transportation Authority Board – ACTION 2017 Strategic Plan adoption
April 25, 2017	Sponsors may submit Fiscal Year 2017/18 Prop AA allocation requests for May CAC/June Board action

## Prop AA Vehicle Registration Fee Program Update

- 2012 Strategic Plan programmed \$27.1 million to 22 projects
- To date: \$23 million allocated
- 11 projects are open for use
  - City College Unity Plaza & Pedestrian Connector opening ceremony October 1<sup>st</sup>, 11am
- Final two allocations for Geary Boulevard transit improvements anticipated in this fiscal year.
