Summary of Requests

Total of \$40 million in Prop K funds requested:

- Paratransit operations
- Two Van Ness Corridor Signals projects
- Two Neighborhood Transportation Improvement Program (NTIP) projects
- 19th Ave Combined City Project
- Transbay Transit Center
- Three BRT Allocations
 - Geneva/Harney
 - Geary (near-term and full BRT)

Paratransit – Operations (SFMTA)





- Prop K Request: \$10,193,010
 Leverages \$11 million in non-Prop K
- Partial funding of broker contract for FY 2015/16
- Broker procures and manages service provider contracts, administers client eligibility, manages fares collection, acts as customer service representative for SFMTA
- New in FY 2015/16: improved group van services

SFgo Van Ness Corridor – Construction (SFMTA)





- Prop K Request: \$2.275 million, leveraging \$14 million in federal funds
- Improves traffic signal infrastructure and transit on-time performance
 - Conduits, mast arms, signal heads, pedestrian signals, transit signal priority, and a new communications network
 - Part of the Van Ness Corridor Transit Improvement, supporting BRT
 - Through a Construction Manager/General Contractor contracting method
 - Scheduled for completion in late 2018

Franklin Divisadero Signals Upgrade (SFMTA) Construction






- Prop K request: \$3.2 M
 - Total project: \$5.5 Mi ncluding \$1.6 M in Prop AA
- 32 upgraded intersections
 - 10 locations recommended in WalkFirst
 - New Pedestrian Countdown Signals at 24 intersections
 - Design completed earlier in 2015
- Open for use December 2016
- Fulfills commitment to allocate FY 15/16 funds

Potrero Hill Pedestrian Safety and Transit Stop Improvements [NTIP Capital] – Construction (SFMTA)








- Prop K Request: \$60,000, leveraging \$477K in Lifeline Transportation Program funds
- Safety/placemaking barriers at five intersections:
 - ► 25th/Connecticut; 25th/Texas-Dakota
 - ► 23rd/Dakota-Missouri; 23rd/Arkansas
 - Missouri/Watchman
- Per SFCTA's Potrero Hill Neighborhood Transportation Plan, HOPE SF's Rebuild Potrero, and SFMTA's Green Connections
- Scheduled for completion by the end of 2015

Lombard Street Corridor [NTIP Capital] – Design (SFMTA)






- Prop K request: \$846,586
 - Includes \$400,000 in District 2 NTIP Capital funds
- Design for 14 curb bulbs at 5 intersections
- Coordinated with SFPUC work and Caltrans paving project, which will begin in 2018
- Includes early construction:
 - Leading pedestrian interval signal timing at three intersections
 - Daylighting, advanced stop bars, continental crosswalks at 14 intersections
- Includes appropriation for Transportation Authority project support (\$75,000)

19th Avenue Combined City Project (CCP) – (SFCTA) Design






- Prop K request: \$75,000
- Advisory role for SFCTA on SFPW's design phase of 19th Ave CCP project
- Project improvements:
 - Transit (bus bulbs, red zones)
 - Signal (upgraded, larger signals)
 - Pedestrian (bulb-outs, red zones)
 - Utility (water/wastewater replacement)
- CCP work timed for incorporation into Caltrans paving project
- Anticipated completion for design in November 2016; construction in mid-2018

Transbay Transit Center – Project Management and Construction Management Oversight – Construction (TJPA)





Prop K request: \$14,220,000


Supports Fiscal Year 2015/16 consultant services (construction management/oversight; program management/program controls; property management)



Prop K contributions to date are over \$127 million (~9% of total)

Geneva/Harney BRT Feasibility Study – Planning (SFCTA)





- Prop K request: \$50,000
- Fulfills commitment to appropriate FY 15/16 funds
- Covers San Mateo C/CAG and Caltrain's contributions
 - Feasibility Study completed summer 2015 (approval on today's agenda)
- Planning to be completed by mid-2016
- BRT service operational by 2023 to support shipyard development

Geary BRT – Near-Term Improvements (Phase 1) – Planning, Design (SFMTA)







Prop K request: ~\$2M leveraging \$617K in G.O. bonds

- Transit-only lane (Van Ness to Stanyan)*
- 20 bus, pedestrian bulb-outs*
- Upgraded signals at 10-15 intersections, including countdown*
- Japantown-area pedestrian, traffic calming improvements*
- Includes continued outreach
- Design complete December 2016

Geary BRT – Full BRT (Phase 2) – Planning/Environmental (SFMTA)

- Prop K request: \$6.8M
- Includes full project, including centerand side-running segments*
 - \$6.3M for SFMTA Conceptual Engineering Report (30% design)*
 - Curb layouts, bus bulbs and station designs, underground investigations, utility coordination, electrical design for signals, street lights*
- \$470K for SFCTA to complete environmental requirements

Full project construction anticipated to begin 2019

* Preliminary until environmental process concludes and preferred alternative selected.
